Subject: **ACCEPTANCE OF AGREEMENT NUMBER 2008-23 BETWEEN THE COUNTY OF HUMBOLDT AND THE DRUG ENFORCEMENT ADMINISTRATION OF THE UNITED STATES DEPARTMENT OF JUSTICE**

RECOMMENDATION(S):

That the Board of Supervisors

1. Accept the Agreement Number 2008-23 between the County of Humboldt and the Drug Enforcement Administration.
2. Authorize the Board Chair to sign, upon approval of County Counsel as to form, and the Risk Manager for insurance purposes, the:
 - a. Request for Advance or Reimbursement.
 - b. Certification Regarding Lobbying; Debarment, Suspension and Other Responsibility Matters; and Drug Free Workplace Requirement.
3. Authorize the Sheriff to sign agreement number 2008-23
4. Instruct the Clerk of the Board to return the signed original documents to the Sheriff's Office (Attention: Linda Modell) for further processing.

SOURCE OF FUNDING: Drug Enforcement Administration

DISCUSSION:

Each year, the Drug Enforcement Administration makes available funds for the eradication of marijuana in local jurisdictions. We have received approval for \$175,000. Agreement 2008-23 specifies that the money must be spent by December 31, 2008, for Deputies' overtime, salary and overtime of Reserve Officers during the time they are engaged in activities leading to controlled substance eradication, as well as, appropriate per diem, and some direct costs associated with the arrest of controlled substance violators. This is a renewal of an existing agreement.
